I am glad that Carol Edholm wrote about SEAPEX for the February newsletter. I serve as exhibits chair for the show, and was very pleased to have several new exhibitors, both adult and youth. Carol mentors the youth exhibitors, and Lyman and/or I mentor many of the new adult exhibitors. THIS MONTH'S TOPIC: How do you like the new Uniform Exhibit Evaluation Forms being used by APS judges? Do you find them helpful? Are they better than the old evaluation forms? How do you feel about removing the "points"?

(In response to some recent communication with John Hotchner concerning use of the new forms, he offered the following:)

I had my first experience using the UEEF at Sandical recently, and found it a good combination of utility for both the judge and the exhibitor. I have never received one, but the reports I get back from exhibitors are mixed. Communication in the best of circumstances is an inexact science - and written communication the worst of the alternatives as both ends of the equation start out with assumptions the other does not understand. Thus, the UEEF is an attempt to substitute written information for what one might get in critique or at the frames where clarification can be asked for and usually obtained. It is better than where we have been, with no feedback for mail-in exhibits (except for what they might ask for by proxy, email, phone, or letter - but most didn't), but it is far from nirvana.

Regarding point qualification for Internationals, one can apply based on receiving a national Vermeil, NOT a specific number of points. That does not mean one's exhibit will be accepted. Organizing committees often have more requests than they can accept, and each has its own selection criteria.

Regarding points and percentages, there is always a hunger for precision, even if it is largely meaningless, or results in confusion. What I have found internationally is that some judges start from 0 and add points according to their perception of how well the exhibit meets the categories. Others start from full points and deduct according to perceived faults. The agreed number once the judges of a given team sort it all out is notional, and a different jury might well arrive at different points. And often they do arrive at different points, unless one is in the Point Stratosphere, at near perfection. For the rest of us, the points too often lead the exhibitor to think that if they can just get one more point in treatment and one more in scarcity, they will get the next medal level at the next show. And so they make improvements, they think, and the medal level at the next show stays the same or maybe even

the points go down. The points, then, must be looked upon as a general guide, but the truly useful information comes in complete sentences and paragraphs.

While I was not involved in developing the UEEF, I think that the thought behind it took this into account. It is helpful for the exhibitor to know how the categories are weighted, but NOT helpful - and often creates misimpressions - for judges to assign points in place of - or even in addition to - text comments. In other words, as comforting as it is to cling to the seeming specificity of points, it is much less useful than a well stated comment. Of course, not all judges are schooled in that art, but I am hopeful that our performance will improve as we use the new form and get more experience. The form itself is perhaps not yet the best it can be to promote understanding by exhibitors, and if you find things about its language that you think could be improved -- or about the process, for that matter -- they should be addressed to Steve Reinhard, chairman of CANEJ.

One of the nice features of the UEEF is that the judge's name who filled it out is present. I'm thinking it would be good to add an email address or mailing address for the judge to promote dialogue when the exhibitor wants to pin down the meaning of a comment. Most judges are happy to do this as they have very specific things in mind when they write the comments.
