I have finally returned from spending 5 months in Mexico and have been going through the WE newsletters in more detail. I would like to respond to one of the discussion topics you have put up. See below.

Since most of us do not have a perfect exhibit on the first try, what methods do you have to track the different renditions of your exhibits?

I have put all the iterations of my exhibit on my website at <http://www.sheryll.net/Exhibit/Exhibit.htm>. I find it very easy to check back on what I have done in the past or to see how I wrote up a certain cover or stamp issue just by looking at my webpages.

I also photocopied major iterations after each stamp show, putting the pages, certificate and critique in a binder with plastic sleeves. My first exhibit was copied in black and white, but I decided to copy subsequent exhibits in color. They are much nicer to look at and they can be scanned, lent out or even used at club displays without worrying about losing valuable items.

As an Aussie, I am a member of the AAPE's down-under equivalent, the interNational Association of Philatelic Exhibitors (known as NAPE). Each issue of their magazine, the Asia Pacific Exhibitor, currently features a member's exhibit, usually a one-frame complete with scans and short introduction to the exhibit. Last year I was asked to provide one of my exhibits for their feature section, and as a result the November issue featured my 5-frame exhibit on New Hebrides / Nouvelles-Hébrides as shown at PIPEX 2009, with scans of selected pages and the synopsis. Most of the scans were in color, including those shown on the front and back covers.
